## Privacy Policy

### Key Terms and Definitions

Deletion of personal data – any action that results in the permanent destruction of personal data so that it cannot be recovered by any means.

Personal Data Information System – a set of databases and technologies used for storing and processing personal data.

Data Anonymization – actions that render it impossible to identify an individual without additional information.

Personal Data Processing – any operation performed on personal data, including but not limited to collection, storage, use, transfer, anonymization, and deletion, whether by automated or manual means.

Website – the collection of informational and graphical content, software, and databases accessible at <https://ventara.host>.

Operator (or “Company”) – Ventara, which determines the purposes and means of processing personal data.

Personal Data – any information that identifies, relates to, describes, or can reasonably be linked to a specific individual.

Automated Processing – data processing performed using computing systems.

User – any visitor of the Ventara website.

Data Disclosure – the intentional release of personal data to third parties.

Data Sharing – making personal data available to an undefined group of people, including publishing online or providing access through telecommunications networks.

Cross-Border Transfer – the transmission of personal data outside the User's country to a foreign entity.

### 1. General Confidentiality Provisions

1.1 This Privacy Policy outlines how Ventara (the “Company” or “Operator”) collects, uses, stores, and protects personal data in accordance with applicable laws, including but not limited to the CCPA, COPPA, GDPR-equivalent standards, and other relevant regulations.

1.2 The Company is committed to safeguarding user privacy and ensuring the responsible use of personal data.

1.3 This Policy applies to all personal data collected through the website <https://ventara.host> and its services.

### 2. Purpose of Personal Data Processing

## **2.1 The Company processes personal data for the following purposes:**

A. To send informational emails and respond to User inquiries.

B. To enter into and perform service agreements.

C. To provide Users with access to services and website functionality.

2.2 Users may receive promotional emails about new services and offers. They may opt out by contacting support@ventara.host with the subject "Opt-Out of Promotional Emails."

2.3 The Company may collect anonymized usage data (cookies, session data) via analytics tools to improve functionality.

### **3. Legal Basis for Data Processing**

3.1 Personal data is collected only when a User voluntarily provides it.

3.2 Anonymized data is processed based on browser settings.

3.3 Technical and organizational measures are taken to protect personal data from unauthorized access.

3.4 Personal data may be disclosed if required by law or legal processes.

3.5 Users may request updates or corrections by emailing support@ventara.host.

3.6 Users may withdraw consent at any time by contacting support@ventara.host.

### **4. Collection and Storage of Personal Data**

4.1 The Company ensures security through administrative, technical, and physical safeguards.

4.2 Measures are taken to prevent unauthorized access or disclosure.

4.3 Disclosure to authorities may occur when required by law.

4.4 Users may request correction or deletion via support@ventara.host.

4.5 Unless otherwise requested, personal data is stored only as long as required for the purposes outlined.

### **5. Categories of Personal Data Collected**

## **5.1 The Company may collect:**

A. Full name.

B. Email address.

C. Residential or mailing address.

5.2 Anonymized data may be collected via cookies or tracking technologies.

### **6. Cross-Border Data Transfers**

6.1 If data is transferred internationally, safeguards such as contractual protections or explicit consent will be applied.

6.2 Users will be notified of such transfers if required by law.

## 7. Additional Provisions

7.2 The Company may update this Policy as needed. Continued use of the website signifies acceptance.

7.3 This Policy is effective indefinitely unless replaced by an updated version.
